Following the acquisition of Schneider International - Moving Excellence in April 2015, the purchase of Transdem is the second investment Harsch has achieved under the leadership of its new CEO Isabelle Harsch. *“There can be no doubt that the moving market is undergoing a period of consolidation. Many players are competing in an almost static market. I believe there will be more companies for sale in the future and thus further opportunities for our group to expand and increase market share”* says Isabelle Harsch.
